



## ***THE FALLS CHAMBER***

### ***RAFFLE RULES, REGS AND DISCLAIMER***

1. The purchase price for one raffle ticket is \$30.00 each. An indefinite amount of raffle tickets will be sold.
2. Ticket entries can be purchased from a Falls Chamber Board Member, or at the Chamber office (58 High St. Somersworth)
3. Tickets may be purchased with cash or check. If your check is returned unpaid by the bank, the entry ticket(s) will be invalid unless a cash payment is received by the Chamber by 3:00 p.m. Friday May 3, 2019. You will also be subject to all associated bank fees.
4. All raffle ticket purchases are final and non-refundable.
5. You must retain the original printed raffle ticket. The stub will be entered into the drawing and will be retained by The Falls Chamber.
6. All unsold tickets and proceeds from the raffle ticket sales must be received by The Falls Chamber no later than 3:00 p.m. Friday, May 3, 2019. If received after the official deadline, all monies will be returned to Entrant(s) and all associated tickets will be invalid. Additional tickets may be purchased with cash through The Falls Chamber at the Annual Awards Event until 8:00 p.m. on the drawing date, Friday, May 3, 2019.
7. The winner of the raffle will be determined by random drawing. The drawing will take place on Friday, May 3, 2019 at approximately 8:30 p.m. at Spring Hill in South Berwick. This information will also be announced on The Falls Chamber website at [www.thefallschamber.com](http://www.thefallschamber.com). You do not need to be present to win.
8. Winners agree to comply with all IRS regulations regarding raffle winnings. Winner(s) agree to furnish The Falls Chamber with his/her social security number, verify his/her identity, and sign all required IRS documents (IRS Form 1099) before claiming prize.
9. The winner of the raffle is entitled to \$2,019 payable by cash or check.

10. The winner of the raffle must claim the prize within 5 days of the drawing. If the winner does not claim the prize within 5 days of the drawing, by responding to phone or written email notice from The Falls Chamber or otherwise, the prize will be forfeited.
11. Purchasers of raffle tickets must legibly write their full names and telephone numbers on each individual ticket stub. If more than one name stated on a ticket stub, the first listed name shall be the winner. The Falls Chamber shall, will and can have no obligation for payment or delivery of any prize to any person other than the Winner. It is the sole responsibility of the Winner to allocate any such prize among the participants in any multiple party entry.
12. Purchasers of tickets, by participating in the raffle, release The Falls Chamber, its directors, officers, members and agents from any and all liability, loss or claim arising out of any raffle prize, and expressly waive any such claim
